("USA Water Ski") allowing the minor(s) identified below (individually and collectively, "Minor") to participate in the USA Water Ski sanctioned tournament, clinic, show, exhibition, race, competition, practice or other event described above (the "Event" or "Events"); I, for myself, and on behalf of Minor, and the Minor's parents/legal guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the "Agreement");

- 1. I hereby represent that (i) I am the parent or legal guardian of the Minor; (ii) the Minor is in good health and in proper physical condition to participate in the Event; and (iii) the Minor is not under the influence of alcohol or any illicit or prescription drugs which would in any way impair the Minor's ability to safely participate in the Event, and that I am responsible for the Minor's safety and well being at all times and under all circumstances while at the Event.
2. WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT

For and in consideration of permission to be allowed as visitors and to participate in water sports and other activities, including, but not limited to the use of all water and terrain vehicles ("Activities") at 10001 and 8670 Holmes Road, Collierville, Shelby County, Tennessee ("Property"), the undersigned, for themselves, their heirs, successors and/or minor participant for whom they sign do acknowledge, warrant and agree as follows:

1. The undersigned understands participation in the Activities is hazardous and involves risks of serious injury, including permanent disability, death and other losses, to both to me and my property. I understand these injuries and losses might result not only from my actions, but the actions, inactions or negligence of others and might occur both during the preparation for, and participation in the Activities.
2. The undersigned agrees that they are responsible for their safety while participating in the Activities. The undersigned agrees to participate only when they are both physically and psychologically prepared and before beginning the Activities to fully familiarizing them self with the premises. The undersigned agrees to use the type and condition of equipment reasonably necessary to safely participate in the Activities.  - a.
